PROFILE OF A MAJOR EXPERT COLLABORATING WITH MVSO AND A MEMBER OF THE MVSO ACADEMIC COUNCIL

Prof. Ing. Bohumil Král, CSc. has been working at the Department of Management Accounting at the Faculty of Finance and Accounting at the University of Economics in Prague as the head of the Department on a long-term basis. He is also the chairman of the Rector's Advisory Board for Finance and Budget at the University of Economics in Prague, chairman of the Academic Council, lecturer and guarantor of courses on financial and managerial accounting at the Prague International Business School, member of the scientific councils of the University of Economics in Prague, Faculty of Finance and Accounting of the University of Economics in Prague, Faculty of Management and Economics of the Tomas Bata University in Zlín and Faculty of Mechanical Engineering of the Czech Technical University in Prague, chairman of the Academic Board of the Czech Association for Financial Management, and lecturer at the Moravian Business College Olomouc.

His scientific and publishing activities as well as implementation of several managerial projects in different enterprises (Ferona, OKD, JUTA, Dvůr Králové nad Labem, Tepelné hospodářství Hradec Králové, Pražská plynárenská, Plzeňské městské dopravní podniky, Státní tiskárny cenin, Technistone, TOS Varnsdorf, TOS Svitavy, KOPOS, etc.) are of great importance.

Prof. Král is also significantly involved in the field of professional education of accountants and financial workers. From 1998 to 2017, he worked at the Chamber of Auditors of the Czech Republic as a member of the Executive Committee and chairman of the Audit Examination Committee. Since 1997, he has been working at the Union of Accountants as the chairman of the Committee for Certification and Education; since 2013, he is a member of the Commission for Coordination of Education and Professional Examinations at the Council for Public Audit Oversight. From May 2017, he is a member of the Presidium of the Public Audit Oversight Board.
